Lifetime Limited Warranty INSULATED GLASS

Effective July 1, 1996, Lincoln Wood Products, Inc., extends a limited warranty on insulated glass for the life of the product for seal failure causing impaired vision due to moisture, film or dust between the glass.

This warranty does not include scratches, cracked or broken glass or damage caused by improper maintenance, handling, misuse, heat buildup or the application of after manufacture film on glass.

For seal failures, Lincoln will furnish replacement glass at no charge for a period of ten (10) years from date of manufacture. After 10 years Lincoln will furnish replacement glass at 50% of the published list price at time of replacement.

Lincoln Wood Products, Inc., extends a limited warranty on insulating glass for a period of one (1) year from date of manufacture for stress cracked glass. The warranty on replacement product will extend for the remainder of the warranty period of the original unit.

This limited warranty specifically excludes any liability for consequential or incidental damages. This limited warranty does not cover labor, shipping expenses or other costs associated with the installation or removal of product for repair or replacement. There are no warranties granted other than as expressly provided.

Limited Warranty GENERAL PRODUCT

Effective July 1, 1996, Lincoln Wood Products, Inc., extends a limited warranty for one (1) year from the date of manufacture on products manufactured by Lincoln. Lincoln will replace or repair, at its discretion, any of its products found to be defective by virtue of materials or workmanship provided notice is given to it within thirty (30) days from discovery of a defect and provided the defect occurs within the one (1) year warranty period. Lincoln may choose, at its discretion, to refund the original purchase price of product if replacement or repair is not reasonably possible. The warranty on replacement product will extend for the remainder of the warranty period of the original unit.

This limited warranty does not extend to:

1. Insulated glass (Covered by separate warranty)
2. Product that is installed in unusual, abnormal, or extreme locations or situations.

This limited warranty specifically excludes any liability for consequential or incidental damages. This limited warranty does not cover labor, shipping expenses or other costs associated with the installation or removal of product for repair or replacement. There are no warranties granted other than as expressly provided.
